

Rates Statutory tuition fee academic year 2025-2026: Enrolment starting September 1st, 2025

Rotterdam University of Applied Sciences charges the statutory tuition fee only if you have met the following two requirements:

1 The nationality principle:

- you have the EEA*, Swiss or Surinamese nationality or
- you have valid residence permit. On the website of DUO you can check whether you meet the conditions: https://www.duo.nl/particulier/tuition-fees.jsp

2 You have not yet obtained a degree in case of a request for enrolment for a:

- Associate degree programme: you have not obtained a associate degree, bachelor or master degree in the Netherlands yet.
- Bachelor's degree programme; you have not obtained a bachelor degree in the Netherlands yet.
- Master's degree programm; you have not obtained a master degree in the Netherlands yet.

If you already have obtained a associate degree, bachelor or master but this is the first time you apply for a course programme in 'health care' or 'education', you are qualified for the legal tuition fee, on the condition that you have not yet obtained a degree in 'health care' or 'education'.

* European Economic Area (EEA); the following countries are member of the European Economic Area: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Mala, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden.
