

Rotterdam University of Applied Sciences charges the statutory tuition fee only if you have met the following two requirements:

- 1 The nationality principle:**
- you have the EEA\*, Swiss or Surinamese nationality *or*
  - you have valid residence permit. On the website of DUO you can check whether you meet the conditions: <https://www.duo.nl/particulier/tuition-fees.jsp>

- 2 You have not yet obtained a degree in case of a request for enrolment for a:**
- Associate degree programme: you have not obtained a associate degree, bachelor or master degree in the Netherlands yet.
  - Bachelor's degree programme; you have not obtained a bachelor degree in the Netherlands yet.
  - Master's degree programm; you have not obtained a master degree in the Netherlands yet.

If you already have obtained a associate degree, bachelor or master but this is the first time you apply for a course programme in 'health care' or 'education', you are qualified for the legal tuition fee, on the condition that you have not yet obtained a degree in 'health care' or 'education'.

**\* European Economic Area (EEA);** the following countries are member of the European Economic Area: Austria, Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Latvia, Liechtenstein, Lithuania, Luxembourg, Mala, the Netherlands, Norway, Poland, Portugal, Romania, Slovakia, Slovenia, Spain and Sweden.

#### Note:

(Prospective) students with Ukrainian nationality will pay a lower tuition fee in the academic year 2023-2024. The institutional rate is equated to the statutory tuition fee rate of €2,314.00.

Current students of Russian and Belarusian nationality will pay a lower tuition fee in the academic year 2023-2024. This concerns an extension of the reduced institutional rate in academic year 2023-2024 for the group of Belarusian and Russian students who re-enrolled in academic year 2022-2023 for the study programme for which they were enrolled in academic year 2021-2022 and who have already paid the adjusted institutional rate in that academic year. In this case, the institutional rate is equal to the statutory tuition fee of € 2,314.00.

Please note: Students of Russian and Belarusian nationality who started a new study programme at Rotterdam University of Applied Sciences in the academic year 2022-2023 and who pay a high institutional rate for this do not fall under the above-mentioned regulation.
